

Share Information

Veoneer common stock is traded on the New York Stock Exchange ("NYSE") while Veoneer Swedish Depository Receipts (SDRs) are traded on NASDAQ Stockholm's list for large market cap companies.

At the end of 2020, the number of shares outstanding were 111.62 million (excluding dilution). The increase from 111.40 million in 2019 comes from vested Restricted Stock Units (RSUs) and exercised stock options. The weighted average number of shares outstanding for the full year 2020 increased to 111.56 million (excluding dilution as we are currently in a loss position), from 101.62 million for the full year 2019.

Stock options (if exercised) and granted restricted Stock Units (RSUs) could increase the number of shares outstanding by 1.7 million shares in total. In addition, the Company may settle the conversions of the Convertible Notes in cash, shares of the Company's common stock or any combination thereof at its election. The number of shares of the Company's common stock issuable at the conversion price of \$22.3125 per share would be 9.28 million shares if the Company elected to settle the conversion wholly in shares. Combined, this would add 9.86% to the Veoneer shares outstanding.

As of December 31, 2020 there were 1.7 million common stock available for future issuance under the Veoneer, Inc. Stock Incentive Plan. There were 111,622,327 shares of Veoneer common stock outstanding. The Company currently does not hold any shares in Treasury.

The Company estimates that there were approximately 45,000 beneficial owners of Veoneer common stock and SDRs as of December 31, 2020. Approximately 12% of Veoneer's institutional investors were U.S.-based and approximately 78% were Sweden-based. Most of the remaining institutional investors were based in the U.K., other Nordic and Central European countries.

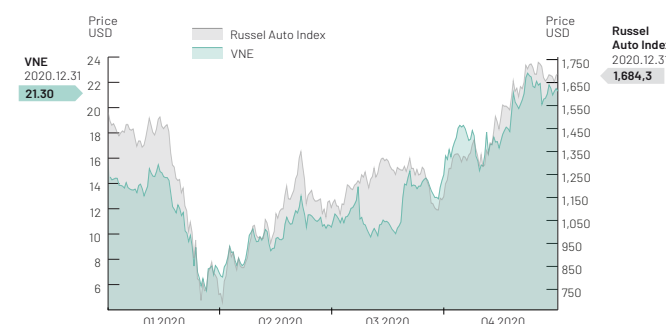
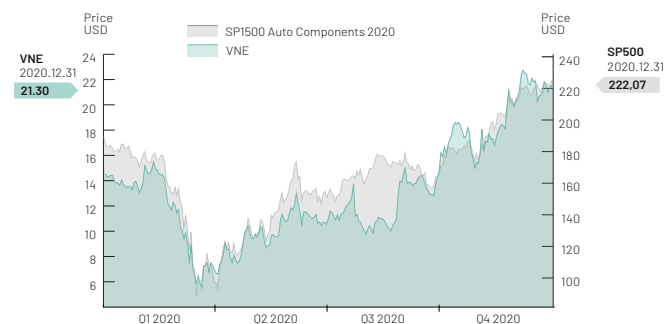
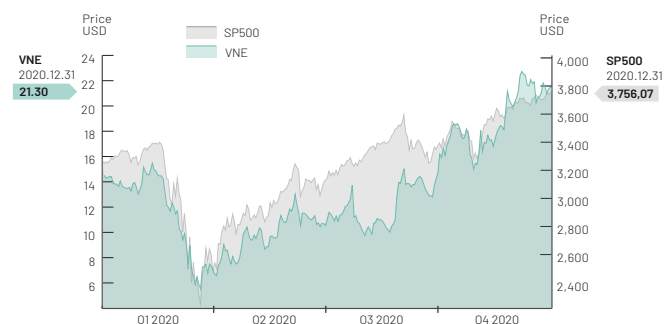
